1 You are cordially invited to participate in the above Innovation Challenge.

OVERVIEW OF JTC INNOVATION CHALLENGE

- JTC Innovation Challenge is looking for innovative solutions that addresses challenges in the built environment, such as: i) reducing life cycle cost of the ownership of building & infrastructure; ii) improving manpower productivity, reducing reliance on manual labour; and iii) reducing carbon impact, improving resilience to shocks to our supply chain. JTC has the intention to subsequently deploy these co-developed solutions into our estates and projects, pushing the adoption into the industry.
- Applicants are invited to submit proposals for the nine (9) Challenge Statements under 3 main statement themes in 3 phases. Details on submission period of each phase are as shown below:

The proposal submitted must clearly state how it addresses the requirements of the Challenge Statement.

You are not required to submit the proposal electronically via GeBIZ.

<u>Step 3</u>: Selected proposals will be notified by JTC via email within two (2) months from the Closing Date of the respective Challenge Statement.
