<u>Step 3</u>: Selected proposals will be notified by JTC via email within six (6) months from the Closing Date of the respective Challenge Statement.

- Applicants shall conform to the requirements of the Challenge Statement and, adhere to the instructions and eligibility criteria.
- Applicants are **strongly advised** to check the JTC Innovation Challenge site (JTC22.innovation-challenge.sg) for any Corrigendum / Addendum which are issued prior to the Closing Date and Time. Acknowledgement of receipt by companies is not required as any published Corrigendum / Addendum is deemed to form part of the Innovation Challenge.
